Position, academic and professional qualifications

Prof Birgit Kuschke is an associate professor in the Department of Private Law, University of Pretoria. She obtained the degrees BLC (*cum laude*) in 1986 and LLB (*cum laude*) in 1988 from the University of Pretoria. She obtained the LLD-degree in 2009 at the University of South Africa for her thesis entitled "Insurance against Damage caused by Pollution." She is also an Attorney, Notary and Conveyancer of the High Court of South Africa.

Academic and professional experience

Prof Kuschke completed her attorney's articles in 1991 with VDT Attorneys in Pretoria. She was admitted as an Attorney, Notary and Conveyancer of the High Court of South Africa in 1994 and practised for her own account from 1994 until 2005 in association with VDT Attorneys in Pretoria, specialising in insurance, engineering, construction and professional services contracts.

She was appointed as lecturer in the Department of Mercantile Law in 1991, and as senior lecturer in that Department in 1993. In 1999 Prof Kuschke also assisted as Commercial Manager of the I-Commerce division of Dimension Data until 2000. She was appointed as senior lecturer in the Department of Private Law in 2000, and was promoted to associate professor on 1 January 2011.

Birgit has been a member of the International Association for Insurance Law ('AIDA') since 1998 and has been involved in various research projects relating to the impact of risks posed by Y2K, electromagnetic fields, environmental pollution, climate change, genetically modified organisms, the effect of genetic testing on the insurance industry and the insured as a consumer.

She currently serves as a Councillor on the Presidential Council of the International Association for Insurance Law, and is a member of two working groups within the Association. She still runs a limited opinion practice with the focus on insurance law, engineering and construction law and other commercial matters.

Teaching activities

Prof Kuschke lectures the Law of Contract modules presented in the Faculty, on both a undergraduate: KTR 210 (Law of Contract) and KTR 220 (Law of Contract), and post-graduate: KTR 810 (*Capita Selecta* of the General Principles of the Law of Contract); KTR 822/GPC 801 (General Principles of the Drafting of Contracts) and ILC 803 (Legal Aspects of Project Management), levels. Prior to 2000 she also lectured extensively in insurance law and on aspects of general commercial law with a focus on tax law and consumer protection law in the Department of Mercantile Law. She is currently the promotor of five doctoral students and study leader for numerous LLM-students for the LLM (Research). She is also the course leader and coordinator for the LLM (Law of Contract) by coursework.

Prof Kuschke designed and implemented the first subject within the Law Faculty to be presented electronically via the internet. She still lectures this subject called Legal Aspects of Project Management (ILC 803) that is presented electronically via Click-UP (WebCT) for the Master's Programme in Project Management (MPM) presented in the Faculty of Engineering, Built Environment and Information Technology of the University of Pretoria.

In addition to her academic responsibilities, Prof Kuschke has lectured extensively since 1997 at CE@UP (Continuing Education at the University of Pretoria) for the Certificate Programme for Project Management (PPM).

Birgit is also an accredited Poslec SETA Education, Training and Development Practitioner, and offers the course on Drafting of Contracts at various Law Schools for candidate attorneys under the auspices of the Law Society of South Africa.
